After examining the above information in detail, the Vice-Chancellor directs that the application be submitted for consideration by the Syndicate and then the Syndicate meeting dated 30.10.2023 resolved to approve the application for suspension of the MA English Language and Literature program (15 seats) for the academic year 2022-23 and for its resumption in 2023-24 as per the resolution item No. 2023.1160* of the meeting.
- 5. The Vice-Chancellor gave permission on file to implement the above decision in the University.
